Upon your request, registered with no. 47820 on the 10th of February 1995, we inform you that, following the investigations performed by our experts between February 10-17, 1995 regarding the incident on the 5th of February 1995 in the apartment on Str. Sergeant Turturica no. 4, bl 70, sc. 1, ap.. 2 sector 5, we reached the following conclusions:

The analysis of the burning pattern and of the material traces found on site (the deformation of construction elements, the existence of a broken connecting pipe between the gas-cooker and the gas pipe, with large deposits of coke, traces of gasoline resulted from the samples taken, the deformation of the bathroom window grating) leads to the conclusion that, on the 5th of February 1995, around 04:15, an explosion took place in the respective apartment, most probably a methane gas one, followed by a fire.

The circumstances that facilitated the occurrence of the explosion cannot be explained within the normal conditions of the apartment at the given time.

Relevant evidence has not been found to sustain your assumption regarding "the detonation of an ammunition load" or due to a chemical reaction.

The color and the smell of the smoke, considered in some statements to be unusual, could be explained by the nature of the materials that burned (rubber, plastics, textiles, etc).

La cererea dumneavoastra, inregistrata la nr. 47820 din 10.02.1995, va comunicam ca, in urma cercetarilor efectuate in perioada 10 - 17.02.1995 de catre specialistii nostri, cu privire la evenimentul produs in data de 05.02.1995, in apartamentul din Bucuresti: Str. Sergent Turturica nr.4, bl. 70 B, sc. 1, ap.2. sector 5, au rezultat urmatoarele:

Analiza amprentei arderii si a urmelor materiale gasite la fata locului (deformarea elementelor de constructii, existenta racordului aragaz-conducta rupt, cu depuneri mari de cocs, urmele de benzina puse in evidenta in probele prelevate, deformarea grilajului ferestrei de la baie) conduce la concluzia ca, in data de 05.02.1995, in jurul orei 04:15, in apartamentul respectiv a avut loc o explozie, cel mai probabil de gaz metan, urmata de incendiu.

Imprejurarile care au creat conditii pentru producerea exploziei nu pot fi explicate in cazul unei situatii normale existente in apartament, in momentul respectiv.

Nu s-au constatat probe concludente care sa sustina ipoteza dumneavoastra privind "detonarea unei incarcaturi de munitie" sau datorita unei reactii chimice.

Culoarea si mirosul fumului, considerate, in unele declaratii, ca fiind neobisnuite pot fi explicate prin natura materialelor care au ars (cauciuc, mase plastice, textile s.a.).
